CHILDLINE is a national, 24-hour, free, emergency phone and outreach service for children in need of care and protection. Initiated in 1996, as a pilot project in Mumbai, CHILDLINE is currently operational in 205 cities across 30 states and UTs in India.

CHILDLINE reaches out to the most marginalized children with the aim of providing them rehabilitation and care from unsafe situations. CHILDLINE provides relief and rehabilitation in the space of shelter, medical aid, repatriation, rescue, emotional support and guidance etc.

### Bandhua Mukti Morcha vs the Union of India

The existence of bonded labour is an offence to human dignity. In India, bonded labour has been illegal since 1976 when the Parliament of India put into action the Bonded Labour System (Abolition) Act. However, the practice is still widespread.

Here goes the story of 8 teenagers rescued by CHILDLINE Shimla.

In a joint operation, CHILDLINE Shimla, the Shimla Police and the District Administration rescued 8 bonded labourers from the custody of horse owners operating in Mahasu peak, Kufri. Hailing from Assam, children were brought to Delhi to work as bonded labour in the horse riding business which was the transit point before the children were sent to Shimla. It was during an outreach programme organised by CHILDLINE Shimla in Kufri that one of the boys approached the CHILDLINE team asking for help.

The CHILDLINE team made a visit to the spot immediately and gathered information. The team also informed Shri Onkar Sharma, Deputy Commissioner, Shimla who assured all his support. He also ordered an inquiry into the matter involving the police and labour departments.

"We were neither given enough food nor a proper place to stay. This has been the most frightful experience I have ever had. I will never step out of my village again. A woman forcibly brought us here from our village and sold us to this employer. We have been working for 14-16 hours every day for the last 6 months" These are the words of an innocent 16 year old boy who was working as bonded labourer until he was rescued by CHILDLINE Shimla.

8 natives of Assam, aged 13-16 years, - Gautam, Bhupesh, Mintu, Saresh, Vishal, Dev, Bhitu and Suren (names changed) were rescued by the CHILDLINE team with assistance from Shimla. These children had been working as horse handlers under the oppressive custody of the horse owner.

"We managed to rescue eight boys living in pitiable conditions with the help of the Deputy Commissioner, the SP, the District Administration and Labour Department, but finding their exact addresses was a tough job as they had little information about the exact addresses," said Anita Sharma from CHILDLINE Shimla

After the rescue, the children were provided immediate care at the CHILDLINE centre. After a long interaction with them, CHILDLINE understood that these poor children were brought from Assam to Delhi on a fixed salary by a woman who called herself Dolma. The children were treated in an inhumane manner for the past 9 months and had not been provided wages for the work they were doing.

CHILDLINE produced the children before the CWC who directed CHILDLINE to handover the children to their parents. CHILDLINE lodged an FIR under Section 16 of the Bonded Labour system [Abolition] Act 1976 while the Shimla Police is in the process to file a charge-sheet. CHILDLINE took necessary steps for the children to be registered as Bonded Labour. The children were provided a bonded release certificate and interim relief money of Rs.1000 each as monetary compensation

by the District Administration under the Bonded Labour Rehabilitation Scheme, Ministry of Labour, Government of India. However, the woman could never be identified even though a case was registered under the Bonded Labour Act.

CHILDLINE traced the addresses of the children which were verified by the officials of the Assam Government. The Home Commissioner, Government of Assam directed the officials of CID Assam to accompany the children to their villages. The children are currently living with their parents.

CHILDLINE is now ensuring that all cases under the Bonded Labour act are made in accordance with the landmark judgement made by the Supreme Court: "Bandhua Mukti Morcha vs Union of India". In this case, the Principal Resident Commissioner Office, Government of Assam instructed the State Home Commissioner to ensure rehabilitation and compensation of Rs.19000 to all rescued children under Bonded Labour Rehabilitation Scheme.

The case also received good media coverage in Hindustan Times, Dainik Bhaskar, Amar Ujiwala, Divya Himachal.

This case illustrates how prompt networking and timely intervention can rescue children.

### **Back to Nagpur**

Maneesh, a ten-year-old boy was living with his parents in Nagpur. He comes from a broken family where his father abandoned him and his mother doesn't look after him. Brimming with anger, Maneesh attacks his father with a stone and runs away from home. He proceeds to board a train which takes him to Kerala.

Incidentally, the Government Railway Police (GRP) officials found Maneesh loitering at the railway station. They immediately sent him to a local orphanage. Not understanding the local language in Kerala and facing cultural differences, Maneesh ran away to Mangalore.

During an outreach, the **CHILDLINE Manglore** team found a child begging on the railway platform. When asked whether he had eaten any food, the boy asked for help. After winning his trust, the CHILDLINE team took him to the CHILDLINE center.

Later on, the child revealed to having issues with his parents. After sharing details of his home town, Maneesh was taken to Nagpur. As the **CHILDLINE Nagpur** team was unable to reach his parents, they left their contact number. The parents immediately called back as they were worried about their son. On the advice of CHILDLINE and the police, Maneesh's parents promised to mend their ways and look after their son in the best way possible.

### The 'un-happy' childhood

Ambika, a two-year-old girl child, constantly beaten by her grandmother and mother was rescued by **CHILDLINE Coimbatore**.

Little Ambika was a victim to her parents failed marriage. She was being beaten, pinched, poked and abused by her grandmother and mother since her birth. CHILDLINE Coimbatore received a frantic call from concerned neighbours informing them about a little girl who was being abused at Ambedkar Nagar Housing Unit, Kavundapalayam. The residents of the housing unit wrote to CHILDLINE to take custody of the children.

CHILDLINE reached the place to find out that Ambika's grandmother believed that her birth was the reason that her daughter and son-in-law had gotten separated. Fortunately, Ambika's 5 year old sister has been spared from the misery.

The irony of this story was that the children had been rescued earlier by CHILDLINE on being tipped off some time ago. Their mother had repented her behaviour and insisted on having her children back. CHILDLINE gave her a second chance and allowed her to look after her children.

On receiving another call from the neighbourhood, CHILDLINE filed an FIR at the Pothanur Police Station. The children were produced before the CWC who directed the children to a temporary shelter home.

### The deceiving shop keeper

"He took me to his shop promising me some sweets. Once I reached there, he began touching me. I shut my eyes and kept quiet because I thought it would escape me. This continued for many months where he would take my hand and make me touch him. I vividly remember the first time it happened. When it was over, he threatened me saying that if I ever spoke of this to anyone he would kill me..."

These are the words of an innocent 10 year old girl rescued by **CHILDLINE Kasaragod** after being victim to sexual harassment.

Narasimha Naik, a petty trader ran a small shop and gambling den near the Government school in Kasaragod. 20 girls between the ages of 10-12 years were victim to the sexual abuse by this man, who lured these girls with sweets and money for sexual favours in return.

The children were afraid to speak to their parents as they had been threatened by the abuser. This incident came to light when the school teacher noticed money in the possession of the girls and suspected something amiss and began probing further, which revealed that they were being offered sweets and money by the shopkeeper in return for sexual favours. Shocked with the news, CHILDLINE was contacted by the headmaster and teachers asking for immediate help.

The CHILDLINE team took the children to hospital for a medical examination. The situation was serious and the children and their parents required counseling which was undertaken by the CHILDLINE team.

The team also approached the Superintendent of Police at Kasaragod and registered a case against the abuser on the basis of sexual harassment of children under Section 376 (rape) of the Indian Penal Code. Following the complaint lodged by CHILDLINE, a team led by U.Preman, Circle Inspector of Police and K.Rajeev Kumar, Sub-Inspector of Police arrested the abuser at his house in Mangalore.

CHILDLINE Murshidabad lends a supporting hand to 3 girls who stood up against an early marriage



Three young girls from Murshidabad, Tuktuki Khatun, Bithika Das, Adori Pradhan, with little education and almost no support, turned down marriage proposals and showed tremendous courage in standing up against parental and societal pressure. The Honorable President of India was exceedingly impressed by their stories and invited them to the Rahstrapati Bhavan to acknowledge their courage and resilience.

Tuktuki Khatun, a 14 year old girl lives in Kashimnagar gram panchayat with her parents. She was a school dropout who helped her mother to earn a living by rolling beedis and also partook in household chores. Tuktuki had no complaints from life until she was coerced by her family to get married. She refused to get married on the grounds of wanting to complete her education. With support from her friends and the **CHILDLINE Murshidabad** team, Tuktuki managed to convince her parents about the ill effects of child marriage. With great efforts from the CHILDLINE team, Tuktuki now goes to school and lives her dream.

The story of Bithika and Adori are no ordinary stories. Like Tutuki, their marriages too were plotted against their will. 16 year old Bithika Das, lives in Behrampore. Bithika was a bright student studying in class X. Her father sought to arrange her marriage with a forty year old local businessman. She refuted strongly, but her parents continued to pressurize her. Bithika informed her friends about the same who in turn informed CHILDLINE. "With the help of CHILDLINE and other NGOs, the marriage was stopped. I want to go back to school and finish my education. Marriage can wait until I am 19," says Bithika.

Adori Pradhan, a 17 year old girl, belongs to a poor family of

the Mahurul gram panchayat, Adori was a student of class XII when her father arranged her marriage. "I wanted to study and did not want to get married, as our teacher had told us that one should not marry before 18 years," says Adori. She opposed, her parents, but they refused to listen to her. Having failed to convince her parents, she informed a CHILDLINE team member about her plight. The CHILDLINE team then met the parents and counseled them about the ill-effects of child marriage. Adori is currently pursuing her studies at Nabagram College.

The 3 young girls have shown immense courage in battling societal pressure of child marriage. They would have been victims of child marriage at a young age, had they not shown exemplary courage in resisting the same.

Tuktuki, Bithika and Adori have become role models for those girls who are subject to the same pressure in their community.

### **National Directors Meet**

New Delhi: The 14th National Directors Meet, the annual meeting of CHILDLINE Directors, was held from January 3-4, 2012 at United Services Institute of India, New Delhi. The meet marked 15 year celebrations of CHILDLINE with sharing of achievements, challenges and strategies of the CHILDLINE network. It provided a platform for CHILDLINE, partners, representatives from the government, stakeholders and friends of CHILDLINE to come together to exchange ideas, experiences, questions and answers, and debate on the emerging, critical areas in Child Protection.

Dr. Armaity Desai, Trustee, CIF welcomed the gathering. "We say that children are the future of this country. But they are the least concern for everyone, especially when it comes to policymaking," said Armaity Desai, Trustee, CIF. She highlighted the need to see the 'child' as a rights-holder and equal to the adult counterpart. The meet saw release of Child Protection study CIF on the various spaces a child is exposed to and how children-friendly the places are.

"CHILDLINE has, over the years, expanded its mandate from being an emergency service for street children, to an emergency service for children in distress, to a service for all children in need of care and protection but the key principles that we base our functioning on are - Partnership, Listening to Children's Voices, Learn and Share, and Lean Structures and High Impact," said Kajol Menon, Executive Director, CIF

Delivering the keynote address, Ms. Neela Gangadharan, Secretary, Ministry of Women and Child Development and Chairperson, Governing Board, CIF acknowledged the role of CHILDLINE in catalyzing child protection in the country. She appreciated the efforts by CHILDLINE in ensuring child protection at various levels. She highlighted the need to look at children's issues, micro families, nuclear families, employment of women, impact on social lives, all of which have an impact on the present and future generation.

The first plenary session focused on 'Political Economy and Child Rights' which was chaired by Ms. Razia Ismail, National Convener, India Alliance for Child Rights, Delhi. The speakers were Prof. K.B.Saxena, Council for Social Development, Delhi and Mr. Harsh Mander. Founder and Head. Aman Biradari. Delhi. This session set the note for the debates and dialogues that followed, enabling participants to view their work in the field of child rights using a wide angle lens covering national and international political-economic imperatives and drivers that impact the situation and status of children in India.

"Am I only to do rescue? Or am I in the business of prevention? And if I am in the business of prevention, what is it that I must try to prevent? Not a child running away, or the child getting lost but the reasons why that happens and those reasons are not just personal, those reasons are also political. Those reasons are also cultural," said Razia Ismail, National Convener, India Alliance for Child Rights at the Plenary Session.

The two day deliberations touched upon Emerging Areas for Child Protection Intervention focusing on five critical themes namely Emergency Displacement and Migration, Contours of the CHILDLINE Rural Model Program, Children in Conflict Areas, Changing Family Structures and the Impact on Children, Children in Institutions.

The National Directors Meet (NDM) has been an annual feature of CIF since its inception. The partnership meet aims at providing a platform to the directors to share their views and concerns on policy related matters of CHILDLINE functioning and child related issues for the better functioning of CHILDINE services across India.

CHILDLINE launches "The Everywhere Child Project- a child friendly place in every space"

The launch programme began with Dr. Armaity Desai, Trustee, CIF highlighting the need to see the 'child' as a rights-holder and equal to his/her adult counterpart. She said "The need of the hour is to protect and secure a child's childhood. Protection and safety of the child is the responsibility of each and everyone, not just of those directly charged with their protection."

Introducing the study, Dr. Desai stated that it recommended a new approach to addressing the issue of child protection viz that instead of merely looking at child protection issues in general as is now the case. The Study focuses on issues relating to child protection specific to each space through which children traverse. This, she said, was a bold and new initiative taken to highlight the gross inadequacies faced by the child.

Ms. Nicole Menezes, Deputy Director, CIF moved on to present the key findings of the study based on an analysis of data collected from 11 states across the country.

Ms. Nicole mentioned that the Study focused on five spaces (Public Service Space, Education and Health Space, Public Institutional Care Services, Statutory Bodies for Child Protection, Public Safety Space and Common Public Spaces) and that inputs for the Study were obtained from duty bearers, civil society members and children through interviews, focus group discussions and consultative meets. Further, she shared how a major contribution in the Study was the spacewise standards recommended, which was evolved through extensive consultations held with civil society groups and experts on the subject of child protection.

Dr. Syeda Hameed, Member Planning Commission, Government of India released the publication. While acknowledging the Study and the fresh approach to child protection, she appreciated that the Study had taken into account the voices of children. She said she hoped to present

this different approach to child protection in the Planning Commission discussion forums and talked on how a framework could be evolved from the Study for the Planning Commission to demand accountability from the States.

The launch ended with initiating a dialogue on safe spaces for children who was paneled by Mr. Jose Bergua (Chief Child Protection, UNICEF, Delhi), Mr. Tom Thomas (CEO, PRAXIS Institute of Participatory Research), Ms. Nina Nayak (Chairperson, KSPCR), Dr. Aditi Mehta (Principal Secretary, Women and Child Development, Govt. of Rajasthan) and Dr. T. Kumar (Principal Secretary, Women and Child Development).

# The Everywhere Child Project - a child friendly place in every space, launches across India

### Mumba

On 12th February, 2012, the national study on child protection mechanisms was launched at the YMCA International House in Mumbai.

Ms. Kajol Menon, Executive Director, CHILDLINE India Foundation (CIF) introduced the study and spoke on the occasion, saying, "Over two million phone calls made by children were received by CHILDLINE last year proves that there are voices that need to be heard and matters that need to be addressed. To ensure that an environment conducive to a safe and protected childhood is created and sustained, it is important to define the boundaries of the environment and develop child protection standards for those spaces."

"It is a reality that there are so many cases of abuse and ill treatment in schools and we need to ensure that CHILDLINE 1098 is available in educational institutions for children," said Farida Lambay, Co–Founder of NGO Pratham, Mumbai. Key findings of the survey brought to light issues like 28 per cent of schools did not have separate toilets for boys and girls, only 10 per cent schools reported having a child protection policy and 64 per cent schools said that they take no measures to ensure safety of children outside school premises.

The programme ended with initiating a dialogue on safe spaces for children. Panelists Bobby Sista, Founder and Executive Trustee, Population First, Mumbai, Dr. Nilima Mehta, Former Chairperson, Child Welfare Committee, Mumbai, moderator for the session, Mr.Nishit Kumar (Moderator), Head, Communication & Strategic Initiatives, CIF, Farida Lambay, Co–Founder of NGO Pratham, Mumbai and Ms. Alpa Vora, Consultant, Child Protection, UNICEF were also present.

"Children are citizens of the country, they are equal shareholders and for that we need to frame policies- not out of charity but out of responsibility towards them. Child labour should not be treated as a hazard in the industry but as a matter of great shame for the entire nation. In order to make spaces safer for children we need to view the problem from the perspective of a child," said Ms. Alpa Vora, Consultant, Child Protection, UNICEF. "It is important to create a child protection movement in the country and child protection should go beyond the Juvenile Justice Authority (JJA) and other legislation pertaining to children", she added.

Dr. Nilima Mehta, Former Chairperson, Child Welfare Committee, Mumbai said "The idea that children have rights of their own, which transcend the family settings is a concept that needs to be universally accepted. Society has a special responsibility towards children whose vulnerability and dependence makes it mandatory for parents, adult authority figures and society as a whole to make a special response in law a practice. We need to ensure that they are protected against abuse, violence, exploitation and neglect".



### Kolkata

With the objective of sharing the major findings of the study with professionals, practitioners and NGOs working in the sphere of Child rights and protection, the study was further introduced in Kolkata on 14th March, 2012 at ICMARD, Kolkata.

The release of the study saw a wide participation from senior level NGO functionaries from reputed organizations- Sreema Mahila Samity, Jayaprakash Institute of Social Change, City Level Programme of Action, Society for participatory Action and Reflection, Vivekananda Lok Siksha Niketan, Sabuj Sangha, Socio-legal Aid Research and Training Centre, Center for Communication and Development, Centre for Environmental and Socio-Economic Regeneration, Haiderpur Shelter of Malda, Asansol Burdwan Seva Kendra, Prabuddha Bharati Sishu Tirtha), Representatives from NGOs like Save the Children, UNICEF, Hope Foundation, International Justice Mission, Representatives from media houses (i.e. Times of India, Bartaman), Coordinators and Team members from respective CHILDLINEs and other CIF staff members from

The study was introduced by Ms Nicole Menezes, Deputy Director, CIF who spoke on the transformative approach of the CHILDLINE service from a reactive model to a a preventive model, one that ensured not only secondary or tertiary prevention but also primary prevention of various core maladies of Child Protection.

Mr. Sandeep Kumar Mitra, Head, East Regional Resource Centre further discussed the position of child protection in a national context with emphasis on the existing policies, legislations, programmes and standards that are being maintained for specific child related spaces, the purpose of the study, the key findings of the study, the process followed in acquiring data and the way forward.

This was followed by a panel discussion moderated by Prof. Joydev Mazumder, Director, Vidyasagar School of Social Work. The other panelists for this session were Ms. Paromita Neogi, Child Protection Officer form UNICEF, Mr.Partho Roy, State Representative to NCPCR and chief functionary of Kolkata Consultant and Mr. Bishwarup Banerjee from Save the Children. Furthermore, thematic areas for discussion were allotted to the panelists i.e. Child Marriage – Paromita Neogi, Child Trafficking and interventions-Mr. Bishwarup Banerjee, Education and Child Labour- Mr. Partho Roy.


Presentations on each topic were made by the respective panelists. Some very pertinent questions and issues were raised by the participants. Some of the participants were of the opinion that at times, community based fundamental structures served as the root cause of the problem.



### Bangalore

The national study was disseminated in Bangalore on 30th March, 2012. 115 participants from the CHILDINE network and other major stakeholders attended this gathering. The session was inaugurated by Ms. Nina Nayak, Chairperson KSCPCR.

The findings of the national study were discussed in context to Karnataka. The discussions were focused on four major spaces, namely public services, public safety spaces, common public spaces and community based non-residential spaces. Advocacy initiatives within the four spaces were prioritized as per the needs prevalent in Karnataka. Working groups of experts were constituted for each of these four spaces to debate, help carry out operations and determine the scope of coverage for the study.

13 Schools in Mumbai participate at the Teacher Training Workshop **Child Sexual Abuse (CSA)** 



The 3rd Child Sexual Abuse (CSA) awareness workshop at CHILDLINE saw a battalion of 36 volunteers; both teachers and lady volunteers participated with full gusto. This group was one of the most involved and enthusiastic groups of the CSA programme.

Held on the 7th and 8th of January at YMCA international, Mumbai, the CSA awareness training was conducted to acquaint the volunteers with the principal objectives of the programme. This included an overview of CSA related issues (knowledge) and practical communication skills to prepare them for taking on the task of sensitizing children in schools.

This workshop was a little different from the previous ones as it was the first time that we had invited teachers from 53 schools where awareness sessions has already been conducted. Of these, 13 schools sent two teachers each; one from the Primary and the other from the Secondary sections. The aim of inviting teachers was to explore the possibility of making the awareness sessions for children an integral part of the school curriculum.

Children retain better when sessions are repeated year after year and since volunteers would find it difficult to do so, it is best that teachers who are part of the school establishment are trained to deliver. To ensure that we imparted the best training for such teachers and volunteers, the two day training was designed to combine the best of knowledge and skills set combination.

The first session on Day 1 i.e 7th January was one that participants had been waiting for. Volunteers initially had only a vague idea on the '1098 service and how it works'. The session to provide clarity on the CHILDLINE service was conducted by Kiran More, Committed Communities Development Trust (CCDT), a CHILDLINE partner.

This was followed by a session on 'Child Protection and Child Rights (CPCR)' conducted by Nishit Kumar, Head-Communication and Strategic Initiatives, CHILDLINE India Foundation. Starting with a test on 'Rights in India'; Kumar took the participants through the rights given to the Citizens of India by the Constitution, and those specific to children, while introducing them to the United Nations Convention on the Rights of the Child (UNCRC).

The next session that forced all the participants to put on their thinking caps and understand real life case studies, was the session by Suchismita Bose, Director of The Foundation, on 'Understanding the issue of CSA'. Bose covered the entire spectrum of CSA- covering what is CSA, signs and symptoms that one could watch out for, handling disclosure etc.

Amal Solanki, a working professional and a volunteer said, "I was really worried about my lack of knowledge about the issue. All I knew about CSA was what I had gathered from media reports; this session really helped me get a clearer picture. If it wasn't for the training I would have been quite lost on the field."

Jaya Aiyappa, a counselor and sex educator conducted the 'Child Psychology' session. Emphasizing on the care and compassion approach, she said, "It's crucial for parents and teachers to always 'be there' for children, believe in them and use non threatening mediums such as play therapy to help the child heal." Discussing how the impact of CSA differs on the basis of the severity, duration and the age at which abuse takes place, Aiyappa also helped volunteers understand a child's feelings of guilt, shame, betrayal, powerlessness and helplessness.

The next day began with the crucial session on 'Communication Skills' conducted by Sneha Shah and Shashank Gupta from Isra- Centre for Training & Development. They ensured that the workshop was dedicated only for practical training wherein the participants not only practiced their story telling skills, but also realized the important role that body language and non verbal communication play in creating an overall impression. The session also gave the volunteers tips on handling difficult children in the audience or dealing with difficult situations on the field.

Gloria Gonsalves, a teacher from St. Paul's Boys High School, Dadar said, "I am really glad that my school sent me for this training. It'll help me in conducting sessions for the children. I am sure the Communication Skills session has helped all of the participants tremendously."

The volunteers were provided with their school lists drawn up according to their area and language preference; post the wrap up session conducted by Anubhuti Lal, Project Coordinator, CIF and Sneha Kupekar, Asst. Project Coordinator, CIF. The two day workshop resulted in the training of 24 teachers and 11 lady volunteers as 'Certified Trainers in CSA Awareness.

# HPCL and CHILDLINE team up to introduce a Rescue Van in Mumbai, Delhi & Kolkata

With the expansion of CHILDLINE to every city/district of India, conducting quality intervention and rescue operations in the absence of sustainable funds became a great challenge.

As a complimentary tool to the 1098 service, HPCL tied up with CHILDLINE to provide a vehicle that was available to the CHILDLINE team whenever they needed to undertake a rescue, whenever a child needed to be rushed to the hospital or if outreach programmes needed to be conducted in public spaces.

Currently, 3 vans are running in Mumbai, Delhi and Kolkata respectively. As this project has been running successfully for the last 6 months, we aim to provide a rescue van in those areas where public transport is unavailable to our team, where rescue operations are not up to the mark and where the awareness of 1098 remains low.

Today, with the help of the rescue van we have been able to reach 922 children and 945 adults through 93 outreach programmes and rescued 38 children in Mumbai, Delhi and Kolkata.







# CHILDLINE Srinagar organizes a consultation on the JJB Act

**CHILDLINE Srinagar** along with Child Rights and you (CRY) organised a day-long consultation to discuss child rights and protection issues in Jammu and Kashmir (J&K). The meet encapsulated the Juvenile Justice Act and strategies chalking out the way forward.



Speaking on the occasion, Ms. Nighat Shafi Pandit, Director, CHILDLINE Srinagar said, "The aim is to arrive at a blueprint on changes needed in the current juvenile justice framework in Jammu and Kashmir, and its enforcement status. The need of the hour is a robust implementation mechanism to ensure a better juvenile justice system is in place. Civil society and the government need to ensure that children and adolescents are prevented from being exposed to severe danger."

The meeting saw participation from Mr. Naseer Aslam Wani, Home Minister, J&K, Mr. Ali Mohd. Sagar, Minister of Law & Parliamentary affairs, J&K, Mr. Hilal Parray, Director, Social Welfare, Md. Yasin , Additional Secretary, Social Welfare Department.

Raj Ali Muhammad Sagar, Minister for Rural Development and Panchayati said that "the Government is committed towards the protection of juvenile rights and legal measures are being taken to safeguard and strengthen juvenile rights."

"The Government will shortly formulate a new law to safeguard and uphold the rights of the children, a bill to this effect is being shortly introduced in the ensuing assembly session that would further strengthen the already existing law", he added.

The meet concluded that the key areas being focused on are: increasing the age limit of children from 16 to 18 years, which was covered under the act and formation of the Juvenile Justice Board and Child Welfare Committee.

# Children Speak up at the Children's Gram Sabha

The Panchayati Raj Ministry, Government of Karnataka issued an order (638-2007 dated 30.10.2007) making it mandatory for all Panchayats to provide children a platform to raise their issues and concerns directly with their elected representatives at the Children's Gram Sabha.

CHILDLINE Bidar with support from the District Administration conducted 77 Children's Gram Panchayata during November and December 2011. The Children's Gram Sabhas hold the local government accountable to children and ensures their commitment to children's rights. It also has a powerful impact on strengthening local governance.

Hundreds of Children from Bidar, Humnabad, Basavakalyan, Bhalki, Aurad taluks took part in the Children's Grama Sabha. They kept the spectators spell bound with the display of their talent in various cultural activities -- folk dance, classical dance, drama, music.

### **Workshop for Media personnel**



**CHILDLINE Shillong** organised a National Initiative for Child Protection (NICP) Workshop for media personnel on November 8, 2011 at Press Club, Shillong.

Editors and Correspondents from the media fraternity - TV, Radio and Print media attended the workshop. The objective of the initiative was to sensitise media personnel on child rights and protection; make the participants aware of existing policies and legislative measures pertaining to protection of children. 51 participants attended the programme.

Experts took sessions on Juvenile Justice Care and Protection of the Children's Act 2000, child friendly media, role of the media and an introduction to CHILDLINE. The discussions focused on the sensitivity of communicating children related issues through media and selection of appropriate messages. Keeping 'child rights' as the focal theme, Rabina Subba, Advocate, Legal Rights Forum spoke at length on the origin, features and objectives of the Juvenile Justice (Care and Protection of Children) Act 2000, a primary legal framework for juvenile justice in India.

She said that "the Act provided for the prevention and treatment of juvenile delinquency and a framework for the protection, treatment and rehabilitation of children in purview of the juvenile justice system and a great caution must be observed while reporting cases pertaining to juvenile justice."

On the role of media and issues concerning welfare of children in Meghalaya, Farida Warjiri, Head of Department, St Edmunds College, Shillong in her session highlighted how children were being traumatised by the media. Warjiri stressed on the fact that the media should focus on remedial measures regarding children's issues as opposed to individuals and their plights, spread awareness and encourage public opinion.

Juvenile in conflict with law, the Juvenile Justice Board, the Child Welfare Committee, objectives of their constitution and their purview of operation, legal provisions under the JJ Act and legal provisions under IPC were other issues discussed at the session.

# Children of North 24 Parganas ask questions on child protection

Today, CHILDLINE feels proud to have sown the seed towards a more sensitive and aware culture towards child protection in the minds of the children themselves. In 2012-13, CHILDLINE aims to involve about 50,000 children in the 2nd edition of CHILDLINE Challenge.

### CHILDLINE opens its 3rd booth in Coimbatore

CHILDLINE Coimbatore with support from the Coimbatore Corporation and the Police Department launched the 3rd CHILDLINE booth at Singanallur bus stand, Coimbatore. This was a part of extending the service and reach to children in distress. G.S. Nayagam, Director, Faithful Security, S.K. Jayaraj, Assistant Executive Engineer, Coimbatore Corporation, and P. Chandra Mohan, Assistant Commissioner of Police, East (Law & Order), were present during the launch of the new booth.

"CHILDLINE has also formed a support group with the involvement of auto drivers, bus drivers, conductors, people running telephone booths, who would report if they spotted wandering children. Doctors, nurses, police personnel, staff of ICPS and others were also integrated into the programme," said S. Umadevi, CHILDLINE Coimbatore. We had planned to conduct full-day sessions for teachers and police personnel to cultivate a child-friendly attitude. We receive a lot of complaints about corporal punishment." she added.

According to Fr. Xavier, around 655 children have been rescued from Coimbatore through the 1098 service from January to November 2011 while 584 children were rescued in 2010.

"The other 2 booths were functioning at Coimbatore Central Railway Station and Kavundampalayam respectively. The booths are open during the day, when there is movement of people and traffic in the area is at its peak. The initiative started six years ago and offered services to over 30 children a month," he said.

# CHILDLINE Ranchi organizes a workshop to address the issue of substance abuse

"Those between 5 and 18 years are falling prey to addictions such as sniffing glue, lodex and petrol. Irresponsible family members, difficult family circumstances and poverty has lead them to substance abuse," said N.K. Tah, Director, **CHILDLINE Ranchi**. Children get cash through petty theft at night, another worrying offshoot of substance abuse, he added.

CHILDLINE Ranchi in collaboration with the National Institute of Public Cooperation and Child Development (NIPCCD) organised a workshop on substance abuse at the International Library and Cultural Centre. The workshop aimed to address rise in the number of children indulging in substance abuse in Ranchi.

According to figures available with CHILDLINE Ranchi, 70 children were found indulging in substance abuse between 2008 and 2012 from localities notorious for drug peddling. These areas include Bargain Bustee, Madhukam Bustee, Hatma Bustee, Argora railway station, Khadgarha bus stand, Dibdih, Karbala Chowk among others. In 2008, less than 5 such cases had been reported.

Speaking on preventative strategies, Alka Nizamie, Director of academics at Deepshikha said, "This trend is alarming and the need of the hour is a sustained campaign with the help of police officers. Parents should also keep a tab on whom the child is mingling with and the places they are frequenting," she said.

It was collectively decided that a youth group should be formed in each locality to involve children in activities. The outfit should prepare a list of dropouts and identify the points where children and drug peddlers meet. A peer group can counsel children and stop this menace. Efforts should be made to enroll children in school to distract them from the use of substance.

# NICP workshop for Gaonburas in Northeast India

CHILDLINE Dimapur organised a day long workshop for Gaonburas and community leaders of Dimapur on September 23, 2011. The workshop aimed to create awareness on CHILDLINE 1098, equipping them with knowledge on child rights violation, child rights and protection and the Juvenile Justice System.


N.Hushili Sema, Deputy Commissioner, Dimapur addressed the community leaders during the inaugural session and appealed to them to cooperate and extend their support towards
